# 11. Change in LICS policy: what impact on RTA? (Frédéric Blanqui)

This year, LICS decided to put no a priori limit on the number of accepted papers. This results in an important increase in the number of submissions

and accepted papers, and some important change in the organization of talks.

Some remarks made:

- Submission deadline after LICS results?  $\Rightarrow$  problems with conference date and other conferences
- Acceptance rate not essential if quality is good; conferences should be a place where to LEARN
- The fact that LICS papers may have short presentations could be an argument in favour of RTA giving more time to explain your work. On the other hand, some remarks are made about the possibility that the introduction of short publications in the RTA CfP could lead to fewer submissions to the associated RTA workshops.
- Improve refereeing process of RTA (see POPL, etc.)
- Broaden the scope of RTA by inviting in PCs more people outside the core of the rewriting community

#### 12. Towards a merge of RTA and TLCA? (Frédéric Blanqui)

- Pierre Lescanne claims for a stronger support of new ideas and research lines in RTA.
